RESOLUTION DECLARING SECOND FAILURE OF BID FOR THE SUPPLY AND DELIVERY OF VARIOUS INFORMATION & COMMUNICATION TECHNOLOGY EQUIPMENT FOR THE GAMES AND AMUSEMENTS BOARD

WHEREAS, the GAB advertised Invitation to Bid for the Supply and Delivery of Various Information & Communication Technology Equipment for the Games and Amusements Board in the GAB website, the PhilGEPS and on conspicuous place.


WHEREAS, such advertisements were posted firstly on June 13, 2016, and which conclusively declared a first failure of bidding and re-published (re-bid) the same on July 6, 2016 with sufficient time horizon as prescribed by the Implementing Rules and Regulations of RA 9184 and despite such series of publications/invitations, in the same reasons, no prospective bidder submitted their bids;

WHEREAS, the BAC declares **SECOND FAILURE OF BIDDING** as no bidder participated in the said undertaking, to which the BAC recommends to proceed to another process the bidding law may provide, stated in Sec. 53.1 of RA 9184 which states that "Two Failed Bidding, Where there has been failure of public bidding for the second time as provided in Sec 35 of RA 9184 and its IRR." It is also under this stipulation that an alternative method through **NEGOTIATED PROCUREMENT** be followed.

NOW, THEREFORE, in view of the above premises, WE the members of the Bids and Awards Committee (BAC) hereby **RESOLVE**, as it hereby **RESOLVED** that **AFTER TWO (2) FAILED BIDDINGS**, proceed to **NEGOTIATED PROCUREMENT** for the supply and Delivery of Various Information & Communication Technology Equipment for the Games and Amusements Board under Sec 53 of the Revised Implementing Rules and Regulation of RA 9184.


