**INVITATION TO RE-BID**

**“Supply and Delivery of Various Information & Communication Technology Equipment for the Games and Amusements Board”**

1. The Games and Amusements Board, through the General Appropriations Act 2016 intends to apply the sum of **One Million and Four Hundred Eighty Six Thousand Pesos (₱ 1,486,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Various Information Technology Equipment for the Games and Amusements Board (PB-2016-01Re-bidding)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Games and Amusements Board now invites bids for **“Supply and Delivery of Various Information & Communications Technology Equipment for the Games and Amusements Board”**. Delivery of the Goods is required within **thirty (30) calendar days after receipt of the Notice to Proceed**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

*Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.*

4. Interested bidders may obtain further information from Games and Amusements Board and inspect the Bidding Documents at the address given below during office hour (8:00 a.m. to 5:00 p.m ) from Monday to Friday,

A complete set of Bidding Documents may be purchased by interested Bidders starting July 6, 2016 to July 25, 2016 from Supply Section - 2<sup>nd</sup> Floor Legaspi Towers 200 Paseo de Roxas St., Legaspi Village, Makati City and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos (P5,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The Games and Amusements Board will hold a Pre-Bid Conference on **July 13, 2016 at 3:00 p.m.** at 2<sup>nd</sup> Floor Legaspi Towers 200 Paseo de Roxas St., Legaspi Village, Makati City, which shall be open only to all interested parties who have purchased the Bidding Documents.

5. Bids must be delivered to the address below on or before **July 25, 2016 at 12:00 pm.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **July 25, 2016 at 3:00 pm.** at 2<sup>nd</sup> Floor Legaspi Towers 200 Paseo de Roxas St., Legaspi Village, Makati City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
