As of March 2011, there were eight (8) uniformed PNP personnel on detail to the GAB-AIGU in accordance with PNP DPRM Special Orders No. 3972. Their assignment covered from periods September 24, 2010 to March 24, 2011. In a letter to then Honorable Sec. Jesse M. Robredo on March 9, 2011, the GAB Chairman wrote for an extension of said detail-assignments but this was denied in a subsequent letter by Police Senior Superintendent Francisco B. Peñaflor, Jr., Senior Police Assistant at the Department of Interior and Local Government (DILG).</p>
