Description

INVITATION TO BID FOR
PROCUREMENT OF ONE (1) UNIT UTILITY VAN

- The Games and Amusements Board (GAB), through the General Fund – 101 under Capital Outlay of the 2015 General Appropriations Act intends to apply the sum of One Million One Hundred Thousand Pesos (P1,100,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of One (1) unit Utility Van. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The GAB now invites bids for Procurement of One (1) unit Utility Van. Delivery of the Goods is required within seven (7) days upon receipt of the Notice to Proceed (NTP). Bidders should have completed, within last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from BAC-Secretariat with telephone Nos. 812-57-13 & 816-3128 and the complete set of Bidding Documents may be purchased by interested bidders starting January 8, 2015 (Thursday) to January 15, 2015 (Thursday), during office hours (9:00 am to 5:00 pm) from BAC-Secretariat, at the address given below upon payment of a non-refundable fee in the amount of P5,000.00 not later than the submission of their bids. The Bidding Documents shall be received personally by the prospective bidder or their authorized representative.

5. The Games and Amusements Board will hold a Pre-Bid Conference on January 16, 2015 at 3:00 pm at GAB Chairman's Office Conference Room, 2nd Floor Legaspi Towers 200, Paseo de Roxas St., Legaspi Village, Makati City, which shall be open only to all interested parties.

6. Bids must be delivered to the address below on or before January 28, 2015 (Wednesday) at 12:00 pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on January 28, 2015 (Wednesday) at 3:00 pm. at GAB Chairman's Office Conference Room, 2nd Floor Legaspi Towers 200, Paseo de Roxas St., Legaspi Village, Makati City,. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
